AMENDMENT OF THE LIEN CREATION FORM AND SUBMISSION OF LIEN CERTIFICATE ON THE SECURITY DEPOSIT.

- We refer to Section 37 of the Insurance Act, Cap 191, and Regulation 16(2)(c) of the Insurance (Capital Adequacy and Prudential Requirements) Regulations, 2020.
- 2. The Authority, in collaboration with the Bank of Uganda, has observed that the lien creation form currently used by insurance entities does not provide sufficient control over the withdrawal of the security deposit. To address this shortcoming and enhance the control process, the lien creation form has been revised accordingly.
- 3. You are therefore required to amend your existing lien creation form using the updated version "here attached" and submit the following by 11th June 2025:
 - a) A fully completed, signed, and approved lien creation form (as per the revised format) by your designated primary dealers.
 - b) The corresponding Lien Certificate.
