## APPROVAL OF AGENTS TO HOLD MORE THAN ONE INSURANCE LICENCE FOR THE SAME CLASS OF BUSINESS (HEALTH INSURANCE EXCEPTION)

- The Insurance Regulatory Authority of Uganda (the Authority), in execution of its mandate under Sections 11(1) (a) of the Insurance Act, Cap. 191, to regulate, supervise, monitor and control the insurance industry in Uganda, and in exercise of its powers under Section 86(2) of the Act, hereby issues this Circular. Section 86(2) of the Act provides that "an insurance agent shall not act for two or more insurers transacting the same class of insurance business without the written approval of the Authority."
- 2. Pursuant to the above provision, the Authority has reviewed the current market circumstances relating to health insurance distribution and determined that an exception is warranted in order to enhance access to health insurance products for the public.
- 3. Accordingly, the Authority shall hereby **approve an exception** permitting agents of insurers that **DO NOT** offer health insurance products to be licensed to also act for one additional insurer (offering the same class of business) that provides health insurance. This approval shall also apply to agents of Health Membership Organisations (HMOs).
- 4. This approval is subject to the following conditions:
  - i) The additional licence shall be restricted to health insurance business only;
  - ii) All agents must remain compliant with other applicable provisions of the Act, Regulations, and Guidelines issued by the Authority;
  - iii) The arrangement is disclosed and acknowledged by both Principals.

5. The Authority shall continue to monitor compliance and reserves the right to review or withdraw this approval should circumstances so require. All insurers, HMOs, and agents are required to take note of this circular and comply accordingly.
