LICENSING OF RISK ADVISORS, LOSS ASSESSORS AND LOSS ADJUSTERS FOR THE YEARS 2024 AND 2025.

- 1. As you may be aware, the Insurance Act, 2017 (Act) (Section 82 (1) of the Act refers) requires all persons intending to carry on the business of Risk Advisor, Loss Assessor and Loss Adjuster in Uganda to be licensed by the Insurance Regulatory Authority of Uganda (Authority).
- 2. In this connection, please apply through the online licensing platform available on our website (www.ira.go.ug) and submit all the requirements together with evidence of payment of the non-refundable application (licence) fees of Ugx. 400,000/= per type of business by 31st August 2023. Failure to apply by that date and/or submission of an incomplete application will attract a penalty.
- 3. We also take this opportunity to remind you of the following for the eventual issuance of the licence:
 - (i) All Loss Assessors/Adjusters and Risk Advisors' licences will be renewed by 1st December 2023 for two (2) years. Please note that we shall, at an appropriate date in the future, inform you about the key documents you shall be required to submit to the Authority as evidence of continued compliance.
 - (ii) Professional Indemnity Insurance Policy

A copy of a Professional Indemnity insurance policy of a sum insured of at least one hundred million shillings expiring on or after 31st December 2024 will be required. Additionally, avail us a copy of your External Auditor's professional indemnity insurance policy of a sum insured of at least one hundred million shillings expiring on or after 31st December 2024.

(iii) 2022 Audited Financial Statements

Please ensure that when you submit your licence renewal application, you should have attended to all queries the Authority may have raised regarding your 2022 audited financial statements and returns.

(iv) Obligations due to IRA

You should have fully paid all obligations due to IRA i.e. fines, interest, etc. by the time you submit the licence application.

(v) 2023 Deposit Annual Contribution

Provide evidence of your deposit annual contribution for the year 2023 by **31**st **October 2023**, as you will be advised.

(vi) The Insurance Training College of Uganda and the Uganda Association of Engineering Valuers and Loss Assessors

You will be expected to produce documentary proof of membership to the Insurance Training College of Uganda and Uganda Association of Engineering Valuers and Loss Assessors for the year 2024 i.e. copies of the membership Certificates.

(vii) Company Annual Return 2022

You will be required to avail us with a copy of your company Annual Return duly registered with the Uganda Registration Services Bureau.

(viii) Immigration Status

You will avail the immigration status of all your non-Ugandan employees i.e. a photocopy and original work permit. The latter will be returned immediately after certification of the photocopy.

(ix) Tax Identification Number

Please provide us with a copy of your company's Tax Identification Number

- 4. The granting of licences will continue to be subject to the provisions of the Insurance Act 2017.
- 5. Please note that for all your activities/conduct during the year 2023 the clearance of the Authority's queries will be taken into account when you are being considered for the year 2024 & 2025 licences. Your offices, too, should be adequate and presentable (the Authority's Guidelines on Head Office and Branch Office premises, already distributed to you,

refer). Additionally, you should observe our Guidelines regarding the rotation of External Auditors.

6. Audited Financial Statements for the year 2023

We take this opportunity to advise that while submitting your 2023 audited financial statements, please ensure that:

- (i) The Regulatory Returns are submitted together with the duly audited accounts as they are part and parcel of them, and all of them should be duly signed; and
- (ii) Originals of the audited financial statements and Regulatory Returns are submitted and not photocopies.
- (iii) All of the above should be submitted by 29th March 2024.
- 7. The Authority shall publish the list of those who will be licensed for the years 2024-2025 on **Monday**, 1st **January 2024**.
- 8. Any Risk Advisor, Loss Assessor/Adjuster who may not have been published as duly licensed by **Monday**, 1st **January 2024** will have to meet its publication costs.
