# DIRECTIVE ON HEAD OFFICE AND BRANCH OFFICES OF INSURANCE PLAYERS BY THE AUTHORITY

- 1. The above subject matter refers.
- 2. It has come to our attention that some insurance players either open and close branches and agencies and/or change the location of their Head offices, branches or Agencies without notifying the Authority which could lead to failure of the Authority to carry out its supervisory functions.
- 3. In view of the above and for or the better carrying into effect the provisions of the Insurance Act 2017 and the Regulation made thereunder, the Authority, in exercise of the powers prescribed by Section 121 (1)(b) of the Insurance Act 2017, hereby directs all Insurers, Reinsurers, Health Membership Organisations, Micro-Insurance Companies, Insurance Brokers, Risk Advisors, Loss Assessors, Third-party Administrators, Bancassurance Agents and Corporate Agents to:
  - (a) Within two (2) weeks of receipt of this Directive submit the list of agencies and Branch Office in the format provided for in the table below
